Each vendor will have an assigned space in order to provide an equal opportunity for all.

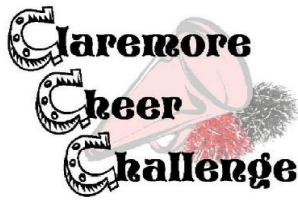
Vendor passes will be issued on Friday at the event as long as a completed reservation form has been received.
