Instructions: Choose an Option:

(Total amount collected and turned in, fundraiser obligation is met)
- 2. Option 2: Sell 5 Program Shout Outs**
(\$100.00 is collected; \$75.00 is credited towards the fundraiser)
- 3. Option 3: Choose any fundraiser and pay the difference if required amount is not met.**
